Following are just a few noteworthy collaborations:

ISPOR and DIA. We are hosting a pre-conference workshop during DIA 2016 entitled, "The Evolving Role of Payers in Drug Development: Pricing, Pharmacoeconomics, and Health Technology Assessment." The workshop will be held on Sunday, June 26, 2016, in Washington, DC, USA, and moderated by President-elect Lou Garrison.

ISPOR and FDA. Representing ISPOR, I recently participated in an invitational meeting on the US Food and Drug Administration Modernization Act (FDAMA) Section 114. The session addressed strategies to promote the use of health economic data to pharmacy and therapeutics committees and other health care decision makers.

ISPOR and EUnetHTA. CEO Nancy Berg attended the Kickoff Meeting for EUnetHTA Joint Action 3 in Amsterdam, The Netherlands. More than 125 government officials involved in the development or administration of HTA included ISPOR in their discussions, and recognized the Society for its role as a resource and a forum to exchange information regarding HTA decision making.
