- * Real World Data = RWD
- * Real World Evidence = RWE

Discussion Session I: State of the Art in Using RWD & RWE in HTA, moderated by Dr. Sukyeong Kim

- > What are RWD and where do they come from? What are their characteristics and advantages?
- > What is RWE? For what purposes can RWE be used?
- What are the limitations of RWD and the key challenges in using RWD in HTA? How should we take systemic approaches/good research practices to collect, analyze, and interpret RWD for HTA purposes?
- Which type of HTA is more likely to rely on RWE and why? In your/your agency's view, how useful are the currently available guidelines/recommendations for the use of RWE in HTA? What are the gaps of knowledge, policy and practice to enhance the use of RWE in HTA?

Discussion Session II: Using RWD & RWE in Asia Pacific, moderated by Dr. Isao Kamae

- How is RWD currently being used in HTA practice in Asia Pacific? Are there any policies for use of RWD in HTA in your organization/country? What are the views and experience of your country in the use of RWE for pricing and reimbursement decisions?
- How do stakeholders get involved in HTA in Asia Pacific? How different are diverse stakeholders' views and acceptability towards RWE? How can we continue stakeholder dialogue on these topics?

Discussion Session III: Future of Using RWD & RWE in HTA in the Region, moderated by Dr. Isao Kamae

- In light of the benefits of RWD and currently fragmented landscape of RWD in the region, how can we strengthen and expand collaboration among HTA agencies on study designs and analytic methods development for generating robust RWE from different sources? What role can ISPOR play in fostering such a collaboration?
- What are your key takeaways from this Roundtable? What is the one thing you want most from ISPOR? How can ISPOR help your organization/country/region?
